1. DIRECTIONS

All documents are required to undergo notarization, consular certification, or apostille authentication either in the country of issuance or via the issuing country's consulate located in Korea.

Applicants must submit the original certified document along with a notarized English translation, for documents issued in languages other than Korean or English.

All notarization must be performed in the document's country of issuance and must certify both the original document and its translation as a single, unified set.

Any document that is translated into Korean and notarized within Korea will be rejected.

(#2 & #3) Applicants must submit a copy of their own passport as well as copies of their parents' passports. If a parent does not possess a passport, a notarized and translated copy of the parent's national identification card may be submitted instead.

#2-A. Applicants who have been issued a Residence Card (formerly the Alien Registration Card, ARC) while residing in Korea are required to submit a photocopy of both the front and back sides of the card.

* In cases where the Residence Card is under extension, a Certificate of Foreign Resident Registration (Form C322B) must be submitted in place of the card. [p. 6](#)

(#4) Applicants must submit a notarized document that officially establishes the parent-child relationship.

(#5) Applicants are required to submit their high school graduation documents along with their academic transcript. These documents must be translated, notarized, and legalized through either consular certification or an apostille.

(#6) English Track applicants must submit a score of TOEFL (CBT 197 / iBT 71), IELTS 5.5, TEPS 601 (NEW TEPS 327), or CEFR B2 or higher.
Korean Track applicants must submit proof of Korean proficiency via a score from TOPIK, a certificate from KIIP (사전 평가 증명서, 이수증, or 교육 확인서), or a Sejong Institute Certificate of Course Completion (excluding online courses).

(#7) Applicants must submit an original Verification of Deposit showing a minimum balance of KRW 20,000,000, held under the applicant's or a parent's name. The deposited funds must be frozen and remain inaccessible until after the semester has commenced.

(#8) Applicants are required to submit the Academic Record Verification Agreement in order to ensure a fair and transparent selection process.

These requirements are specific to applicants from Bangladesh.
